News of Friends affected by Los Angeles area fires

Robin Durant provided news of Friends affected by wildfires in Los Angeles City and County. "Our meeting has tried to reach out to evacuated members to ensure they're safe. Our pastoral care committee took on the job of contacting people in the burn/evacuation zones. We've heard from most of them now. Tomorrow, we're meeting to attend to the debris at the Meetinghouse and to brainstorm. Even something as simple as a phone tree might be helpful to have in place in the case of unthinkable circumstances. We also have a sharing fund, which we might choose to supplement. We used to have a hospitality list of people who had rooms to offer traveling friends. In the era of instant communication, we've let some of the old analog ways slide."

Clerk's report

The Clerk reported on the session's theme, What Should Friends Be Doing Now? His report is attached to these minutes.

The clerks of both quarters have been asked to provide State of the Quarter reports to the Representative Committee. He expects to be working on that in the next four weeks.

Nominating report

Nominating Committee clerk Mary Miche reported that there are no new nominations being brought to this session. Ministry & Spiritual Care and the Children's Committee need more members. The committee is currently Working on job descriptions.

Naming Committee report

Shana Mae Slight (Nevada) gave the Naming Committee report. They do not have any names to bring to the session. The other Naming Committee member Dan Beck is currently in the hospital and is unable to work.

Martha Hunkins (Humboldt) gave the Treasurer's Report, which is attached to these minutes. The fall quarter lost \$905. Losses continue, though not as much as during the pandemic. Our weekend sessions are more costly with lower attendance. The Clerk reported that the Finance Committee plans to meet to address how future

Thom McCue (Live Oak) gave the M&SC report. The committee is organizing Zoom meetings in the spring with monthly meeting committee clerks. The committee is looking for advice on what Friends would like to be addressed in these sessions. They are looking for meetings that are seeking care and help with issues in their meetings.

Registrar's report

Sarah Tyrrell (Berkeley) gave the registrar's report. 56 people registered for the session. Her report is attached to these minutes. The Clerk reported that the teens are having their own event in the Sierras next weekend.

Clerk's proposal for need-finding committees

The Clerk shared an outline of quarterly meeting needs. That outline is attached to these minutes. He noted that the CPQM took on more work in the past than it does now. He invited Friends to join the Need Finding Working Groups.

After a short period of worship, the plenary took a break from 10:49 am to 11:02 am.

First Hand reports from meetings and worship groups

Live Oak Meeting/Soledad Worship Group

Jeff Richman, Amos Johnson, Emelyn Buskirk gave the report for Live Oak Meeting and Soledad Worship Group

Amos Johnson reported for the Soledad Worship Group. Amos has served as clerk of the worship group. He appreciates that the group is not judgemental of people in prison. The Meeting cares for people for who they are and not what they did in the past. No one asks why they are in prison. He invited Friends to join worship groups and workshops in prisons.

Emelyn Buskirk has also attended the worship group and believes that those in prison minister to her as much as she ministers to them. She believes that the reason why Live Oak is such a vibrant meeting is because of their work in the worship group. The Clerk invited the group to send a written report.

Grass Valley Meeting

Dorothy Henderson gave the report that was postponed from the fall session. She reported on the land transition. The pandemic and Jones Fire resulted in the closure of Sierra Friends Center. Friends have died. Others have been forced to move after losing their houses in the fire. Grass Valley Meeting is now conducting its worship on Zoom. They have been reading the anti-racism books recommended by the yearly meeting. The last book they have been studying is authored by a former chair of the Nisenan people who have now regained title to the land. Their organization, CHIRP, has invited Grass Valley Friends to continue worshiping in the meetinghouse.

The meeting's Witness Committee was created by joining their MInistry and Social Justice committees. They are drafting a letter, reaching out to other meetings for support.

They will be available in the lunch time break out groups for questions.

San Francisco Meeting

Diane Bunch, clerk of the San Francisco Meeting, gave the report. They have been assisting the homeless people who are sleeping in front of the meetinghouse.

They are renting out some of the space to groups providing health services to the homeless. The upstairs was being rented to a group providing job services to the homeless, but that group lost its funding, so that space is vacant. Since commercial space is not in much demand now, the meeting is having financial troubles. Unfortunately, people are being deterred from coming because they are fearful of those living on the streets. If they stay in the meetinghouse, they will need to raise money needed to make major repairs. An alternative would be to sell the property and move to a different neighborhood. Another would be to develop the property for housing that would include space for San Francisco Meeting. They are looking for feedback from CPQM Friends on these decisions. The Clerk noted that the quarterly meeting archives are housed in the San Francisco Meetinghouse basement. Diane said that the housing alternative would have space for the archives.

Friends House residents' report

Elizabeth Boardman gave the Friends House report, which is attached to these minutes. She provided a brief history of Friends House and FASE. Friends House is now a part of Front Porch, which has been able to stabilize their financial situation and make needed repairs. They have added solar panels and electric vehicle charging stations. She will be available at a lunch time session for questions.

Stephen Donahoe reported for the Friends Committee on National Legislation. FCNL is also focused on the question of what Friends should be doing now. He thanked the quarter for their active and financial support of FCNL.
